# CITY OF HIGHLAND, KANSAS REGULAR COUNCIL MEETING CITY HALL DECEMBER 14, 2016 7:00 P.M.

**COUNCIL MEMBERS PRESENT:** Charles Batchelder, Dana Clary, Ben Gilmore, Matt Peterson, and Jerry Twombly.

7:00 p.m. Mayor Scott Sisk called the regular city council meeting to order.

Charles Batchelder moved and Jerry Twombly seconded a motion to approve the November 9, 2016 regular meeting minutes. Motion carried 5-0

Ben Gilmore moved and Charles Batchelder seconded a motion to approve the bills as presented for the month of November 2016. Motion carried 5-0

#### **PUBLIC COMMENTS:**

Jerry Twombly suggested contacting Westar to ask for maintenance or replacement of street lights in the eastern part of town. Also, Mr. Twombly indicated Dan Freeman would like to be included in any electrical bids the city may have.

### **COMMUNICATIONS AND REPORTS:**

Mayor Sisk and Aaron Leach reported Allied Systems, Inc. installed the submersible pump today and all pumps are currently working. The council was in agreement the need for yearly maintenance on these pumps.

City of White Cloud contacted Mayor Sisk in regards to the old Christmas lights. There are 17 units (wreaths & candles) and the mayor suggested the lights be donated to White Cloud. Jerry Twombly moved and Dana Clary seconded as motion to give the old Christmas lights to the City of White Cloud. Motion carried 5-0

Mayor Sisk asking for permission to seek bids to seal, oil and chat West Missouri and West Avenue; West Pennsylvania may need some milling before resurfacing and possible include South Kansas in the project for 2017. Mayor Sisk will meet with Councilman Batchelder to further review streets prior to seeking bids.

Doniphan West Booster Club is soliciting funding. Matt Peterson moved and Ben Gilmore seconded a motion to support our schools by giving \$100 to the Mustang All Star level. Motion carried 4-1

Attorney Collins drafted a salary ordinance although the ordinance cannot be finalized until the Council makes some decisions which will need to be made before December 31<sup>st</sup>. Attorney Collins recommended holding a special meeting, possible next week.

Clerk Karn recommends signing an agreement with Karlin & Long, LLC for the 2016 audit which is not to exceed \$5,400. Ben Gilmore moved and Charles Batchelder seconded a motion for Mayor Sisk sign an agreement with Karlin & Long, LLC for the 2016 audit which is not to exceed \$5,400. Motion carried 5-0

Clerk Karn and Ben Gilmore reviewed the budget indicating funds were within the budget numbers. Cash in the funds are projected to be similar to prior year except the water fund which was anticipated to be lower due to the larger planned 2016 expenditures.

Councilman Twombly was checking on the condition of the items to be listed on PurpleWave.

Ben Gilmore suggested a written plan be developed for future large expenditures and prepare for them over a period of years in a line item of the budget. Example – Major expenditure for sludge removal at the lagoons.

Police Chief Whetstine read his report: Arrest -2; Citations -11; Warnings -15; Calls for Service -25; Assist to other Agencies -8; Accident Reports -1; Criminal Investigation -8

Mayor Sisk welcomed Officer Williams back to work after a leave of absence resulting from a vehicular accident.

Aaron Leach addressed the issue of the valve leaking in the water salesman located at the city shop. Parts are difficult to find since the coin operated salesman is out dated. HD Supply has a valve for \$785 with city installation. Jerry Twombly moved and Matt Peterson seconded a motion to purchase the valve from HD Supply for \$785 and use city labor to install. Motion carried 5-0
