ORDINANCE NO. 596

AN ORDINANCE ANNEXING CERTAIN DESCRIBED LAND INTO THE CITY OF HIGHLAND, KANSAS.

WHEREAS, the land to be annexed hereby adjoins the City of Highland, Kansas, and is generally located along the central portion of the northern boundary of said city;

WHEREAS, said land is already receiving certain services provided by said city;

WHEREAS, a written petition for, and consent to, annexation of the described land, signed by all of the owners thereof, has been filed with the City of Highland, Kansas pursuant to K.S.A. 12-520 (a) (7), said lands being described on the plat of survey thereof, which survey is filed in the office of the register of deeds of Doniphan County, Kansas; and

WHEREAS, the governing body of the City of Highland, Kansas, finds it advisable to annex such land.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF HIGHLAND, KANSAS:

SECTION 1. The tract of land described on Exhibit A attached hereto and incorporated herein, is hereby annexed as of January 1, 2024 and made a part of the corporate limits of the City of Highland, Kansas.

SECTION 2. This ordinance shall take effect and be in force from and after its publication in the official city newspaper.
